# Summary and Interpretation of the Preliminary Annual Uniform Crime Report, 2006 Federal Bureau of Investigation

The Federal Bureau of Investigation released its preliminary report regarding crime in the United States in 2006 on June 4, 2007.

#### **Violent Crime**

For the second year in a row, violent crime increased across the country. Overall, violent crime increased 1.3%, but robbery was up 6.0%. Murder rose slightly, with an increase of 0.3%, and both rape and aggravated assault were down, at 1.9% and 0.7% respectively.

When examining violent crime by city size, every single population grouping experienced an increase. However, when looking at the individual violent crimes, there was much fluctuation. The largest increases compared to 2005 data were as follows:

The largest decreases compared to 2005 data were as follows:

By region of the country, the West saw the greatest increase in violent crime, up 2.8% from 2005. The Midwest saw an increase of 2.1%, followed by the South at 0.6%. The Northeast experienced a 0.1% decrease. By geographical region, the Northeast saw the largest increase in murder (2.5%). Every geographical region experienced an increase in robbery, but it increased the most in the West, jumping 11.6% from 2005. The Midwest had an increase of 5.1%, the South increased 4.6%, and the Northeast increased 2.2%.

### **Property Crime**

Property crime decreased 2.9% overall in 2006 compared to 2005. Burglary was up 0.2%, Larceny/theft decreased 3.5%, motor vehicle theft decreased 4.7%, and arson increased 1.8%. Comparing regions, the Midwest was the only geographic area to experience an increase in property crime, up 0.1% over the previous year.



#### **Selected Cities**

In our summary and analysis of the FBI's preliminary report last year, we looked at selected cities across the country. Continuing that selected examination, below are those same cities with both the 2005 and 2006 percentage change in volume.

#### **Authors' Conclusion**

Violent crime increased for the second year in a row. The volatility experienced in 2005 continued in 2006. Although the numbers fluctuate from year to year, the data reveal an unmistakable upward trend. The trends vary by city size (large versus small cities) and by geographical region i.e., West, South. Some cities, for example, experienced increases, while others experienced decreases, and some cities experienced increases only in certain violent crime. The Midwest is experiencing increases in violent crime at higher rates than other areas. Taken together, the data are a continued wake-up call for focusing on reinforcement of crime prevention.
